5. Supervisor's Report

- A. Court Records Resolution 36-2025 Supervisor Napper and councilor Terry audited the court records and found them to be in order. Judge Lawton and Judge Facteau were in attendance and participated in the audit. Motion was made to accept the auditing of the court records. Motion by Tim, second by Tracy all in favor.
- B. Mini Grant- Walkability <u>Resolution 37-2025</u> Authorization for the Supervisor to sign the contract with the county and the Town of Saranac to purchase concrete for sidewalk repairs. Motion by Tim, second by Tracy. Councilor Petrashune abstained and Councilors Terry and Perry were in favor.
- C. Security Keys -Rick will be here tomorrow to work on locks for the conference room and the closet door in the Town Clerk's office.
- D. Executive Order-Hiring Tabled
- E. Heat Pump Situation The electric bill for the courthouse went up drastically and a site visit by the contractor indicated improper wiring as well as other issues. Further work will be required.

- F. Standish Playground Some discussion was held as to what needed to be done at the Standish playground regarding the basketball court. The consensus is to tear up the court and obtain prices on asphalt and concrete before determining what will be used.
- G. Clock-Town Green There are delays on the delivery of the clock for the Town Green
- H. Williamson Law There are continuing problems getting Lisa's computer up to date.
- I. Financial Reports Still working to get annual reviews completed. One of the facts we discovered is that the town does have a substantial liability for underfunding NYS pensions.
- J. Investment Strategy Comptroller called and was pleased to hear that we were using NY CLASS for most of our investments.
- K. Speed Zones Speed research indicated that NYS has little concern for the speed limit on Route 3 near the school because pedestrians and bicyclists are not a substantial factor on that road. NYSDOT indicates a willingness to study the situation but warned that we could possibly lose the current speed limit. The sentiment was to pursue speed reductions on both Route 3 and several of our town roads.
- L. Remodeling The remodeling process continues, the Town Clerk & Secretary's offices are complete. The Supervisor will be moved into the conference room at the end of the week so construction can begin in his office.
- M. Church of Assumption on Water Bill The request by the Church of the Assumption for reduction of their water bill was tabled to allow for formal approval by the Redford water board.
